## **RE: Justice Reinvestment Legislation**

## Dear Governor Raimondo:

Having reviewed the diatribe recently delivered by Attorney General Kilmartin against the passage and signing of parts of the "justice reinvestment" package that will soon be going to your desk for signature, we write to briefly respond and to commend you for your work in organizing the Justice Reinvestment Working Group from which these bills emanated.

As you know, the Working Group – which consisted of literally dozens of stakeholders, including the Attorney General – toiled long and hard to come up with a legislative package designed to promote criminal justice reform in our state. Such reform has been sweeping the country – in red and blue states alike – as more and more political leaders and members of the public realize that the "lock 'em up" mentality that for decades has pervaded many states' approach to criminal justice is ineffective, counter-productive and financially wasteful.

The bills going to your desk are the product of a great deal of compromise. Frankly, we wish the bills were stronger than they are, but we recognize that the final result represents a sincere effort by the dozens of people who worked on this to come up with a package that addressed various viewpoints. For the Attorney General to attack this compromise at this late date is not only unseemly for its vitriol, but also hypocritical in light of the many amendments contained in these bills – amendments we did not support – that were made specifically at his behest.

If the Attorney General is truly interested in "moving forward with actual criminal justice reform," he should be welcoming this package as an important first step, rather than condemning it for seeking to accomplish its purpose.

We know that, as a big booster of justice reinvestment, you recognize that there are many more improvements to the criminal justice system to be made, and we look forward to working with you next year in addressing some of those issues. We also look forward to taking the Attorney General at his word and welcoming his collaboration on further reforms of the system as well.

Some of us served directly on the Working Group, and others of us represent groups working regularly on promoting criminal justice reform, but we all join together in thanking you for your leadership on this important issue.
