CONSENT JUDGMENT

- 2. That the Defendant City of Cranston shall pay to Plaintiff's counsel the sum of **THIRTY-FIVE THOUSAND** (\$35,000.00) **Dollars** in payment of the counsel fees and costs incurred in prosecuting the case, which said sum shall be paid within thirty (30) days of the entry of the within Judgment.
- 3. The claims against Defendant Cavallaro are dismissed with prejudice in consideration of the within Consent Judgment.
