STIPULATION

It is hereby agreed by and between the parties, by their undersigned counsel, that the following shall enter:

- 1. Accordingly, Respondent shall not assert and hereby withdraws any objection to the Petitioner's parole to the community in accordance with the decision and terms set by the Parole Board.

 Upon Petitioner's release to the community on parole, the parties shall enter a stipulation dismissing the above-captioned action with prejudice.
